Comber Community Garden Proposal

A. Overview


The Comber Amenity Site at Glen Link, Comber has recently been vacated. The site is owned by Ards Borough Council. The site is of considerable interest to the local community who would wish this site to be an asset to the Town and its residents. Comber Regeneration Community Partnership would like to take over responsibility for this site in conjunction with Comber Horticultural and District Society to create a Comber Community Garden.

B. Purpose

It is proposed that the site would be converted into a horticultural area containing 2 polytunnels / greenhouse with raised beds around the borders. Open hard stand areas will be used for pots and containers. Comber Horticultural will provide the volunteers to create the garden. The garden will be used to grow both flowers and vegetables including hanging baskets, flower towers and planters. It is intended that the Garden will provide educational areas for local schools which have already shown considerable interest in using this facility. The garden will also compliment the proposed Comber Public Realm project. It is also intended that the Garden be used by local Mental Health/Learning Disability Charities as a working and therapy facility. A core Team from Comber Horticultural will provide custodian, maintenance and technical services for the ongoing management of the Garden. A number of volunteers have already come forward.

The produce from the garden will be used to provide flowers to enhance the town for use in borders, beds and hanging baskets. This will be done in liaison with the Council and Roads Service to enhance the appearance of the Town and encourage visitors and footfall for the shops. Any monies raised from sales of produce will be used to fund the maintenance of the facility.

We would also like to have a close relationship with the Parks Department and also the Fire Station personnel on the adjacent site. Local businesses have also indicated support.
